- [] 11. Submit seven (7) copies of pool plan. The following information must be included as part of pool plan:
- a) Site plan (**Which may be shown on legal survey if desired**) showing pool and associated equipment, including distances from the edge of the pool to each of the following:
 - 1. Lot lines
 - 2. House, garage, and other structures
 - 3. Overhead and/or underground electric utility lines
 - 4. Individual sewage disposal system, or sewer line to house if on public sewer
 - 5. Well, or water main to house if on public water
 - b) Composite pool plan
 - c) Longitudinal section
 - d) Cross section
 - e) Pool wall, deck, and lighting detail
 - f) Diving board detail
 - g) Step and safety rail detail
 - h) Skimmer and return/inlet detail
 - i) Main drain detail
 - j) Fence detail
 - k) Electrical and grounding schematic
 - l) Plumbing and piping schematic
 - m) Volume and surface area of pool
 - n) Method of filling pool with water
 - o) Method of filter backwash and pool water discharge
 - p) Manner of disinfection of pool water
 - q) General specifications and notes
 - r) Type of filter and size in square feet (effective filter area)
- [] 12. Provide a **Notarized** statement from owner that the following safety equipment is provided: A Shepherd's Crook at least twelve (12) feet in length and U.S. Coast Guard approved ring buoy with an attached rope that is at least equal in length to the maximum width of the pool.

NOTES

- PLAN MUST BE PREPARED BY AND BEAR SEAL OF AN ILLINOIS REGISTERED ARCHITECT.
- ALL ELECTRICAL AND PLUMBING COMPONENTS SHALL CONFORM TO STATE OF ILLINOIS AND COOK COUNTY CODES.
- LOCATION OF POOL ON PROPERTY IS SUBJECT TO REVIEW AND APPROVAL BY THE COOK COUNTY DEPARTMENT OF BUILDING AND ZONING.
- IF PROPERTY IS SERVED BY AN INDIVIDUAL SEWAGE DISPOSAL SYSTEM AND THE COOK COUNTY DEPARTMENT OF PUBLIC HEALTH APPROVAL NUMBER IS NOT KNOWN, IT WILL BE NECESSARY TO HAVE A LICENSED SEWAGE DISPOSAL SYSTEM CONTRACTOR LOCATE AND MARK THE LOCATION OF THE SYSTEM.
