


Influenza Surveillance Report Week 4: January 20 - 26, 2013


I. Influenza Summary to Date

Influenza surveillance for suburban Cook County** involves the weekly collection of data from a sample of hospitals, private physician's offices, and laboratory data. Surveillance data suggest that influenza-like-activity (ILI) is currently high. Our sentinel participants reported the following aggregate measures: Syndromic Surveillance: 2.27% ILI¹, Sentinel Sites: 4.65%. One hundred seventy-nine specimens (18.8%) tested by participating laboratories were positive for influenza (94 influenza A H3N2, 49 influenza A unsubtyped, 1 influenza A H1N1, and 35 influenza B). Since Week 35 (8/26/2012), suburban Cook County has had one hundred fifty-three cases of influenza-associated intensive care unit (ICU) hospitalizations. Eight ICU hospitalizations due to influenza infection had onsets during week 4. Thanks to all of our surveillance partners for their help in collecting this information.


II. Syndromic Surveillance Data¹




III. Syndromic Surveillance by Age Group Data¹







- 1. Syndromic surveillance influenza-like-illness (ILI) syndrome is defined as a symptom complex fever and cough or sore throat from ESSENCE. 32 hospital EDs participate in ESSENCE. ILI = # of ED visits for ILI / total # of ED visits.
- 2. ILI is defined as fever ≥ 100°F, cough and/or sore throat in the absence of a known cause other than influenza. 5 hospital EDs and 8 physician offices are participating CDC sentinel sites.
- 3. Laboratory surveillance includes viral culture, RT-PCR, and the rapid antigen test. Not all cases are suburban Cook County Residents. Participating laboratories: IDPH, NSUHS, and ACL.
- 4. Hospitalization and death data are only for suburban Cook County residents (excludes Evanston, Skokie, Oak Park, and Stickney). Data includes reported cases for the presented week.

- † No activity: no laboratory confirmed cases of influenza and no reported increase in cases of ILI.

Sporadic: small number of laboratory confirmed influenza cases or a single laboratory confirmed influenza in a single region of the state.

Local: Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in a single region of

Regional: Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in at least two but less than half the region of the state.

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory confirmed influenza in at least half the region in the state.
